# Paper Mill Redevelopment Takes Another Step Forward

The City of Parchment and Frontier Renewal, the City's development partner, recently announced the sale of property to L.C. Howard Company as part of the River Reach Redevelopment Project. Nearly 20 acres of the former Crown Vantage Paper Company site will be used for new manufacturing and warehousing.

"It has been a long and difficult challenge to redevelop the former mill site," said Parchment City Manager Dennis Durham. "We've

This past summer, L.C. Howard Company purchased the recently closed Georgia Pacific Dixie Plant in Parchment. This project is intended to redevelop portions of the former paper mill site with new manufacturing and warehousing facilities.

"As a result of working with a very enthusiastic and helpful City Hall, we are encouraged and look forward to growing our business in Parchment," said Michael Howard. "We're excited to begin the cleanup and repurposing process on the portions of the Mill we purchased. We're beginning a great partnership with the City of Parchment and are thankful for their input and support."

Redevelopment of prime retail space along S. Riverview Drive occurred in 2013-2015, but this is the first major announcement of significant manufacturing investment. The City has been working with Frontier Renewal, based in Denver, since 2008 to redevelop the 85-acre former paper mill site.

#### Parchment City Commission Votes to Join KABA

The Parchment City Commission voted at its regular meeting of February 6 to approve an agreement to join the Kalamazoo Area Building Authority (KABA) for the provision of building inspection, zoning and ordinance enforcement services. The cooperative agreement between the townships of Kalamazoo and Comstock, and now the City of Parchment, offers a less expensive service option to Parchment taxpayers and an improved level of service to building permit seekers.

"The City's decision to join KABA is an important intergovernmental effort that will eliminate costs and improve customer service," said Dennis Durham, City Manager. "This is good for Parchment taxpayers and good for the organization as a whole." The Paper City Newsletter

### Monthly Brush Pickup Starts in April

Monthly citywide brush pickup will start the first Monday of April—April 3. Brush must be placed at the curb no later than 7 a.m. on pickup day.

Branches, limbs and other tree trimmings cannot be longer than eight feet or thicker than six inches in diameter. Unacceptable items include plastic bags, rocks, concrete, bricks, asphalt or any other item than cannot be composted. Check the City's website for more information.

### Citywide Trash Pickup Scheduled for April

The City of Parchment provides a citywide trash pickup annually for residents. This year on April 26 and 27, Republic Waste Services will be picking up old items left at the curb. This is your one time of year to clean out the basement, garage and closets. Get rid of broken furniture, old mattresses, useless household items. Items left at the curb at 8am.

#### Neighborhood Watch Group On The Job

#### Zoning Board of Appeals Looking to Fill Vacancies

The Parchment Zoning Board of Appeals is a five-member board charged with hearing requests from property owners for correcting errors in enforcing the City's zoning ordinance, as well as granting property variances, when appropriate.

#### Planning Commission Members Sought

The Parchment Planning Commission is a seven-member board appointed by the City Commission to review site plans and enforce building and property rules and regulations.

#### **RENTAL HOUSING REGISTRATIONS HAVE BEGUN**

With adoption of the new rental housing ordinance by the Parchment City Commission in late 2016, new regulations have been enacted requiring rental property owners to register their property with the City. The registrations are necessary to ensure landlords are living up to safety and health codes, as well as livability standards.

Renters living in the City of Parchment can inquire at City Hall about the new regulations.

#### **Fire Department Open House**

#### Saturday May 13th, 2017 8 am to 10 am

As you may or may not know, our City's Fire Department is staffed entirely by paid on call firefighters. That means that there are no full or part time firefighters waiting at the station to answer calls. Instead, each firefighter carries a pager and responds when they can to fire and medical emergencies in the community. This system represents a great saving to you as a tax payer. Firefighters respond only when needed and leave when the emergency is over. In fact, the entire payroll for the department for the year is about \$39,000, less than the cost of 1 full time employee with benefits.

However, to maintain this valuable and efficient system we must have men and women who are willing to serve their fellow citizens. Since the City took over responsibility for the fire department in 1956, it has provided excellent service, with top-notch equipment and staff, following the tradition started by the KVP Fire Department. We need your help in maintaining that tradition and the level of service that makes being in Parchment special. We are especially looking for individuals available to respond during day time hours but are also looking for those available at other times as well.

The benefits in serving your community in this way are many. You will be trained to a Firefighter II level and as a Medical First Responder. You will receive additional training in hazardous materials, emergency driving and other related topics. You will work with outstanding people who bring much talent and experience to the task. And finally, you will have the satisfaction of helping your neighbors in their time of need.

#### **OVERNIGHT PARKING**

Parchment City Ordinance prohibits overnight parking on city streets (between the hours of 3 a.m. and 6 a.m.). Violators will be ticketed.

#### LAWN CARE

Property owners in Parchment are responsible for mowing lawns to prevent noxious weeds and creating blighted properties. City Ordinance prohibits grass or vegetation in excess of 12 inches high.

#### PARKING RV's, TRAILERS and BOATS

City Ordinance prohibits parking RV's, trailers and boats outside an enclosed garage in a front yard for more than 96 hours in a 30-day period. Such vehicles can be stored indefinitely in a rear or side yard provided they are parked on an improved surface and must be properly licensed.
